Test reports N° SN96.39.1 dated 16.10.1996 as per IMO Resolution A.653 (16) and N° TN98.23.1 dated 18.09.1998 as per IMO FTP Code Part 2 from TÜV NORD laboratories, GERMANY.

### **4. APPLICATION / LIMITATION :**

4.1- Both types comply with IMO FTP Code Annex 1 Part 2 for smoke and toxicity.

4.2- Calorific value to be less than 45 MJ/m<sup>2</sup> where required [calculation in accordance with ISO 1716].

4.3- The fitting aboard to be the same as used for the test.
